

**REPORT DESCRIPTION**

- 1 **National Chain Summary Report**

**ALERT** - The FluSTAR system has confirmed an outbreak of influenza in this DMA; flu is widespread and having a significant impact on this DMA. This stage usually lasts from six to eight weeks. Influenza activity is presently greater than 60% of peak levels from prior seasons.

**ADVISORY** - The FluSTAR system is indicating an elevated level of flu-like illness and confirmed flu in this DMA. Influenza activity is presently between 30% and 60% of peak levels from prior seasons.

**LIMITED ACTIVITY** - The FluSTAR system is reporting that flu and flu-like illnesses are at low levels in this DMA. Influenza activity is below 30% of peak levels from prior seasons.

**NO FLU REPORTED** - There is no flu reported for this DMA from within the data sets in the FluSTAR Program.

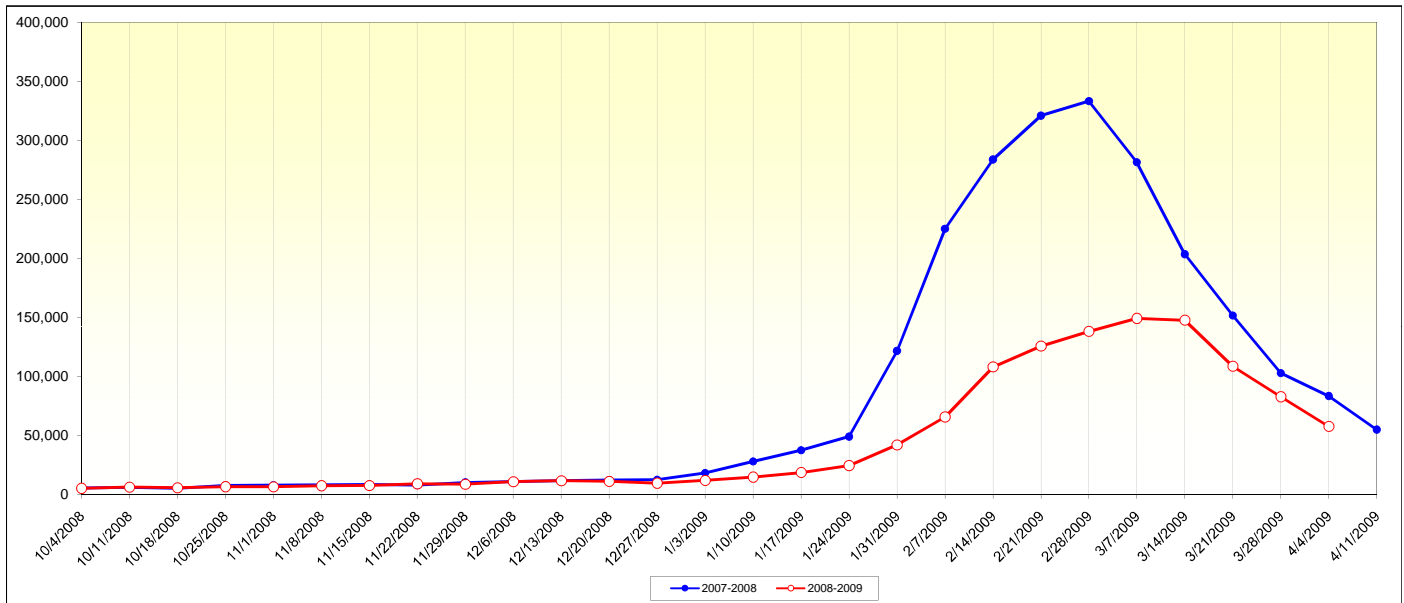


## TOTAL US COMBINED REPORT As Of 04/07/2009
